League growth – 3 new teams confirmed Hollis/Brookline, Upper Valley, Hartford VT

Guest team – Bedford Jaguars – established 8 years to Mite to Midget level in AYF/Pop Warner. Unlimited weight class (won state champ in 07) – is not growing and are looking to grow as a program.

General

John Canu – recognized for growing the program doubling in size

Concord recognized as champions of the league

Need open communication – ALL teams Head Coaches of each team need to speak MONDAY before the game. To ensure field availability, roster numbers, directions ... anything else of importance.

Issues

Ties – none per NHIAA rules

Legal Fields – due to the competitive nature all efforts need to be in place for goal post(s) are in place. Field size needs to be regulation size.

Concord has issues with the city not accommodating enough fields with posts – Newfound is working to fix their issue –

- If you do not have an option mutual agreement is ok if not the other option is to move to other site (the team with the issue will need to align refs)
- Field issues need to be addressed Monday prior to game –

John Stark – Unsportsmanlike conduct on field. The behavior was addressed and corrected (after a period of time) – After complaints from Kearsarge, Newfound, Pembroke and others. As stated this was addressed but, per Sam, not soon enough. Teams need to take proactive steps to police their programs. Problems continued from the rule interpretation of ejected player and scheduled event.

• If player/coach ejected must sit out next LEAGUE game.

Gilford – Practice prior to NHIAA date. Rules state you can do conditioning BUT NOT football drills.

• Gilford was doing conditioning athletic drills

Game Time – 9 and 11 on Saturdays – Bow, John Stark, Kearsarge, Gilford, Upper Valley, Hartford are snow belt teams.

• Varsity plays first on regularly scheduled game – special exception ie night games

Varstiy playing JV – numerous issues of starting Varsity playing JV. *See rule in handbook* –

- Idea put forth on Rosters initial for rosters before Labor Day and every game.
- Idea if you started in the Varsity game you can not play in the JV unless 15 or less on roster. Use non-starters first regardless of position to meet the number of 15.

The final decision was choice 2 - if you started in the Varsity game you can not play in the JV unless 15 or less on roster. Use non-starters first – regardless of position – to meet the number of 15.

What is to few players (roster size) to play –

• If a program has less than 26 players involved that team has the option of not fulfilling obligation of JV team. Again notify the Head Coach of the opposing team by Monday before the game.
